In exercise of the powers No. 11/14/2018-1PP3/ 272 conferred by the proviso to Article 309 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Punjab is pleased to the Punjab Subordinate Services Selection Board (hereinafter referred to as the Board) with immediate effect.

- Constitution of the Board- The Board shall consist of a Chairman and not more than twelve other members and the Board may act notwithstanding the absence on leave or otherwise of the Chairman or any Member.
- Function of the Board- (1) All initial regular appointments to Group 'C' Services or posts under the Government of Punjab except the following shall be made on the advice of the Board-
- Posts in the High Court of Punjab and Haryana.
- Posts in the Punjab Vidhan Sabha Secretariat; and
- Posts on which War Heroes, who have been discharged from ii) defence services or Para Military Forces on account of disability iii) suffered by them or their dependents covered by the instructions issued in this behalf by the Government, are appointed; and
- Such other posts, as many, from time to time, be excluded by the State Government from the purview of the Board. iv)
- It shall not be necessary to consult the Board for suitability of candidates for appointment to:-
- A temporary post, the necessity for which is declared at the time of its creation to be unlikely to continue for more than six months. i)
- Appointment to permanent post of a person temporarily for a period not exceeding six months, owing to emergent circumstances having arisen, it is necessary in public interest, to fill the vacancy immediately and there is likely to be undue delay in making appointment in consultation with the Board;
- Posts to be filled up on contract basis;
- Posts which are to be filled up on compassionate grounds as per iii) iv) government policy; and
- A post to be filled in by promotion or transfer. v)
- Terms and Conditions- The terms and conditions of appointment of the Chairman and Members shall be as may be notified by the State Government
